#### OC Regional Plan Update Recommendation Summary July 19, 2018

#### **BACKGROUND:**

In collaboration with Anaheim Workforce Development Board, and Santa Ana Workforce Development Board, the Orange County's Regional Implementation Plan described three areas: Priority Sector Partnerships, Capacity-Building, and Policy Alignment.

#### 1. Priority Sector Partnerships to Drive Regional Plan Implementation

It's the intent of the Orange County Regional Plan to engage four industry sectors, working with industry leaders to take action that supports sector growth and help residents gain the skills needed to participate in careers in those industries. The four industry sectors are Manufacturing, Healthcare, Information Technology, and Hospitality.

With input from the OC Leadership Council, which is comprised of mandated and community partners described in the OC Regional Plan, a readiness test was conducted to determine the sequencing and timing for new industry sector partnerships. This test included reviews of industry data, assessment of past efforts to engage each sector, analysis of local conditions and market forces, and identification of potential co-chair to lead the industry sector groups. The readiness assessment was completed and Manufacturing, followed by Health Care, were identified as the first and second industries deemed most ready for engagement. It is anticipated that industry launches for these two sectors will take place in the fall of 2018.

#### 2. Capacity-Building to Sustain Regional Plan Implementation

Between now and March 30, 2019, the Orange County Regional Organizer, and the Orange County Training Coordinator will collaborate in delivering a comprehensive series of capacity-building activities to Workforce Development Board members, Workforce Development Board directors and staff, AJCC staff, and OC Regional Partners.

These trainings will focus on:

- Sector Strategies/Business Engagement
- Regional and Local Strategic Planning (alignment with the EDD and State Board Standards)
- Motivating Staff and Building Capacity
- Performance Indicators and Reporting
- Customer Process Flow
- Integrated Service Delivery
- Understanding Labor Market Information

#### 3. Policy Alignment to Support Regional Plan Implementation

The Orange County Regional Organizer and the three Workforce Board of Directors, along with key staff have identified a common set of policies to support the Regional Plan implementation, including priority sectors partnership-building. This alignment process included an assessment of existing polices and programing in terms of support for regional, collaborative industry sector partnerships building. Seven policies were identified.

Currently, the Regional Organizer is working with the California Workforce Association for comments to ensure that the OC Region has identified best practices with these policies. Once finalized, the policies will be submitted to the three regional Workforce Development Boards for approval.

#### Comprehensive Economic Development Strategy Recommendation Summary July 19, 2018

#### **BACKGROUND:**

The County of Orange administers the regional CEDS Committee pursuant to the provisions of Section 302 of the Public Works and Economic Development Act of 1965 (42 U.S.C. §3162), Regulations 13 C.F.R., part 303. Every five years, acting as the CEDS Committee the Orange County Community Services develops the Comprehensive Economic Development Strategy (CEDS), which provides valuable information on Orange County's economic environment along with potential plans for developing and growing the economy.

This five-year strategic plan presents the current condition of the Orange County economy and the impact on those who live and work in Orange County; it identifies economically vulnerable areas in which to invest economic improvement activities; it proposes action strategies in five major areas impacting all of Orange County: infrastructure, workforce and education, housing, innovation in economic development, and healthcare. It is a source of economic, workforce, and demographic information that include the most recent research available on high-unemployment and low-income communities.

The CEDS provides the foundation for all EDA funding applications submitted by Orange County. Applications for funding may only be submitted for areas that meet economic distress criteria. Eligible project areas must have a per capita income that is 80% or below the national average, and an unemployment rate that is at least 1% greater than the national average unemployment rate. The CEDS is prepared every 5 years and must be updated every year. For this iteration of the CEDS, stakeholders from the business and education community will be invited to submit input on the content and strategies throughout the public comment period, the first week of August. In addition, a survey was deployed to quantify stakeholder feedback and input to the CEDS.

The Orange County CEDS is on track to be submitted and approved by December 31, 2018 to ensure eligibility for EDA funding.

The OC Community Services/CEDS Committee, with support of county staff, will include the following goals in developing and implementing the CEDS:

### GOAL 1: Provide World-Class Education, Career, and Workforce Opportunities to Address the Skills Gap

- Ensure that businesses have enough skilled workers to meet their workforce needs with the workforce necessary to compete in the global economy
- Support Orange County's education system at all levels to ensure college-readiness and career-readiness
- Support career and technical education
- Develop and promote targeted education and training programs in Orange County's key high value priority industry clusters – Advanced Manufacturing, Healthcare, Hospitality and Tourism, and Information Technology
- Increase middle-skills industry-valued and recognized post-secondary credentials

 Analyze and forecast new and emerging technological advances and industry and organizational processes that may require additional training and skills development

### GOAL 2: Focus on Residents living in Red Zones (areas of low income/high unemployment)

- Develop targeted EDA project proposals in economically distressed Red-Zone areas to spur revitalization and employment growth opportunities, including targeted alignment of partner resources
- Enable economic self-sufficiency for Red-Zone residents by promoting economic opportunity through educational opportunity, removing barriers to employment and leading to career advancement
- Upgrade the skills of the existing Red-Zone workforce to bolster their abilities and improve the lives of Red-Zone residents

#### **GOAL 3: Promote Key Priority Clusters**

- Encourage expansion and retention of Orange County's Key High Value Priority Industry Clusters as they provide significant economic benefits across a number of complementary and supplementary sectors and industries:
  - Advanced Manufacturing
  - o Healthcare
  - o Hospitality and Tourism
  - Information Technology
- Form Industry Sector groups to promote growth and expansion of companies in Orange County's key industry clusters

#### GOAL 4: Improve Orange County's Economic Competitiveness in a Global Economy

- Promote the County as a national and international center for business, global trade, and development
- Foster positive, business-friendly environment to make Orange County competitive and create and retain good quality jobs
- Increase investment in small business start-ups and promote entrepreneurship
- Identify opportunities to lower the costs of doing business and provide streamlined business services to attract and retain businesses

#### **GOAL 5: Plan for and Develop State-of-the-Art Infrastructure**

- Develop an expanded and improved infrastructure system, including workforce housing, to support economic growth and development
- Support infrastructure that facilitates the efficient movement of goods, energy, information and labor
- Coordinate infrastructure investments with economic development opportunities in unincorporated parts of the County
- Support the expansion of communication networks, such as broadband connectivity, telecommunications, and wireless technologies
- Ensure sufficient supply of workforce housing demand arising from new job creation, including reusing obsolete retail centers for workforce housing opportunities







#### **BACKGROUND**








**PY 2017-18 4TH QUARTER** 




#### TOTAL VISITORS BY PROGRAM YEAR

#### **BACKGROUND**



The program will expand collaborative relationships between the OC Probation Department and Community Corrections Partnerships as well as OCDB in support of innovative strategies that accelerate educational attainment and reemployment for the "supervised population."

#### **BACKGROUND**


The County of Orange/OC Community Services and the OCDB were awarded a \$500,000 grant by the U.S. Department of Labor to implement the Linking to Employment Activities Pre-Release (LEAP) 2 program. The LEAP 2 program aims to establish a Transition Center within the Central Women's Jail and Intake Release Center and assist female offenders in preparing for work upon release. The project serves AB109 inmates who are 60-90 days away from release. The goal of the project is to improve the employment outcomes for transitioning offenders by leveraging and building upon the effective strategies that currently exist within the jail facilities and in the Orange County One-Stop Center System. This innovative and unique grant proposal was made possible as a result of OCDB's collaborative relationships with the OC Sheriff's Department, Probation Department and the OC Health Care Agency.



The Orange County Development Board (OCDB), in coordination with OC Parks, was awarded \$1,000,000 in emergency funding from the State Employment Development Department for the 2017 California Wildfires. On October 9, 2017, the Canyon Fire 2 started near the intersection of the 91 and 241 freeways in Orange County. Of the more than 9,000 acres estimated damaged in the Canyon Fire 2, 7,060 acres are within four County park properties managed by OC Community Resources/OC Parks. Through this funding, OC Parks will clean-up and repair damaged and/or burned areas affected by the Canyon Fire 2.




