#### **PUBLIC COMMENTS:**

#### 1. MINUTES

The minutes of the April 25, 2018 Orange County Development Board meeting were presented for review and approval.

Janelle Cranch motioned to approve the minutes, Ernesto Medrano seconded. Rob Claudio and Doug Mangione abstained. Motion passed.

2. COMPREHENSIVE ECONOMIC DEVELOPMENT STRATEGY ACTION The draft Orange County Comprehensive Economic Development Strategy (CEDS) for 2018-2023 was presented for review and approval.

#### ACTION

Staff provided information on the timeline, development and implementation of the CEDS. Additional information was provided on the five (5) goals that will be included within the report.

The Board discussed the importance of sector partnerships, red zones areas and how they are defined, and priority sectors identified in the Orange County Regional Plan aligning with the CEDS. Additional information was discussed regarding the importance of having an education component incorporated and the opportunity for interested board members to be involved in the drafting of the CEDS.

The following staff directives were discussed:

- Ensure public comments received are evaluated and incorporated into the CEDS Report as necessary.
- Review the process in drafting the report, allowing for the possibility of interested board members and partners to be involved in the development.

A motion was made to approve the recommendations with modifications to recommendation #1:

 Approve the draft 2018-2023 Comprehensive Economic Development Strategy for submission to EDA for 30-day public comment release, submission to Board of Supervisors for approval, and final submission to the U.S Economic Development Administration (EDA).

Rob Claudio motioned to approve. Ernesto Medrano seconded. Motion passed.

#### 3. OC REGIONAL PLAN UPDATE

#### INFORMATION

Staff provided an update on the Orange County Regional Plan efforts.

Staff provided information on the OC Regional Plan, including the collaboration with Anaheim Workforce Development Board and Santa Ana Workforce Development Board, priority sector partnerships, capacity-building and policy alignment.

The Board discussed sector partnerships with education and policy alignment with Anaheim and Santa to support the OC Regional Plan implementation.

#### 4. SOUTH COUNTY JOB FAIR

Staff provided information on the South County Job Fair that took place on Wednesday, June 6, 2018 at the Laguna Hills Mall. The job fair hosted 52 businesses representing approximately 1,100 open positions and 300 job seekers.

The Board discussed challenges to recruit for entry level type jobs, and the necessity of having relative experience to receive higher paying jobs.

The OCDB Election of Officers for Program Year 2018-19 was conducted.

#### Item #2 – ACTION

#### WIOA Title I Career Services & One-Stop Operator Request for Proposals Ratings Recommendation Summary

#### BACKGROUND:

In early 2017, the County embarked on a new procurement cycle for One-Stop System Operator and Career Services, as required under the Workforce Innovation & Opportunity Act (WIOA). This effort included the development, release, and evaluation of a formal Request for Proposal (RFP). Throughout this time, staff has periodically updated the Orange County Development Board (OCDB) on the status of this effort. Below is a brief chronology and summary of activities, and a description of next steps.

#### Timeline

- July 26, 2017. The OCDB discussed the RFP structure and evaluation procedures.
- October 25, 2017. The OCDB discussed the status and framework of the RFP.

#### RFP #012-182810

- October 31, 2017. RFP #012-182810 was released through BidSync.
- January 4, 2018. Deadline for RFP responses.
- February 28, 2018. The OCDB considered Item #5 WIOA One-Stop System Operator & Career Services RFP Evaluation Committee Report, which included a recommended action to approve a list of eligible applicants. On a vote of 5-7 with one abstention, the OCDB voted to take no action on this item.
- April 10, 2018. Consistent with the County's procurement rules and Section I.C.9.c. of the RFP, the County exercised its right at its sole discretion to cancel RFP # 012-182810.

#### <u>RFP # 012-182811</u>

- April 10-27, 2018. County staff reviewed and updated the prior RFP package. The revised RFP updated/clarified what back-up documentation bidders were required to submit and clarified minor questions raised during the prior RFP process. Prospective bidders submitted 52 questions during the prior procurement
- April 30, 2018. RFP #012-182811 was released through BidSync.
- June 21, 2018. Deadline for RFP responses.
- September 25, 2018. Request OC Board of Supervisors to approve funding and vendor selection recommendations and enter into contract negotiations.

• November 20, 2018. Request OC Board of Supervisors approval to enter into negotiated contracts.

On June 21, 2018, eleven (11) organizations responded to the RFP, nine (9) were deemed responsive and two (2) were deemed non-responsive. In total, forty-seven (47) responsive applications were submitted to four (4) RFP Components.

The Evaluation Committee consisted of five (5) subject matter experts including mandated partners, workforce professionals and County staff. The Committee had an initial meeting to discuss the process and receive copies of all responsive proposals along with the scoring sheets. Over the following three weeks, each Committee member reviewed and rated each of the proposals. The Committee then reconvened to consolidate scores. The process concluded with interviews of each of the applicants followed by a final scoring and ranking. The Evaluation Committee's scores are reflected on the Evaluation Committee Ratings Report.

1. Approve list of eligible Applicants outlined on the attached Evaluation Committee Ratings Report, pursuant to WIOA Section 108 (d) (10).

#### WIOA ONE-STOP SYSTEM OPERATOR & CAREER SERVICES FUNDING AWARD Recommendation Summary

#### **BACKGROUND:**

The Workforce Innovation and Opportunity Act (WIOA) Title I Career Services and One-Stop Operator Request for Proposal (RFP) was released on April 30, 2018. This procurement is valid for four years. One-Stop Career Services are currently provided by ProPath, Inc. through a sole source contract that will end on December 31, 2018. Programs under this contract include Job Seeker Services (Adult and Dislocated Workers), Business Services (Rapid Response) and One-Stop Operator. New allocations for these services are outlined below. Contracts will be for eighteen months, beginning January 1, 2019 and ending June 30, 2020. On September 25, 2018, staff will seek approval from the Board of Supervisors to start contract negotiations with recommended vendors within funding estimates.

It is important to note that the funding estimates listed below are only projections and may be more or less based on factors including

- Unspent funds from FY 2018-19;
- Funding agency allocations;
- Provider capacity;
- System needs;
- Timing of funding allocations from funding agencies; and
- Prior years' performance, if applicable.

**Job Seeker Services:** Adult and Dislocated Worker funding is used to fund WIOA services to eligible job seekers in the Orange County Development Area. WIOA funding provides employment and training services to assist eligible individuals in finding and qualifying for meaningful employment and to help employers find the skilled workers they need to compete and succeed in business. Service delivery strategies support workers in activities that align with areas of anticipated economic and job growth.

**Business Services:** Rapid Response funding is used to fund required activities provided by Business Services. Rapid Response is a pro-active, business-focused service that responds to layoffs and plant closings by quickly providing assistance to companies and their affected workers. Rapid Response teams work with employers and employee representatives to minimize disruptions associated with job loss. Rapid Response funding is also intended to provide lay-off aversion services for businesses. Some Adult and Dislocated Worker funds may also be used to supplement Business Service activities.

<u>**Training:**</u> There are two broad categories of training – Classroom-based (Occupational Skills through Individual Training Accounts (ITA)) and Work-based (On-the-Job, Customized). ITA funds and payments have been managed by the County while work-

based funds are incorporated into the provider's contract and managed by them. Beginning on or before July 1, 2019, all training funds will be incorporated into the provider's contract and managed by them. The OCDB will still provide administrative oversight and manage the Approved Training Provider List.

**One-Stop Operator:** The One-Stop Operator (OSO) and the Adult and Dislocated Worker Career Services Providers fulfill two distinct and separate roles within the local workforce system. Since the OSO wishes to serve as the Career Services Provider, they must have appropriate firewalls in place between the staff providing services, the staff responsible for oversight and monitoring of services and the OCDB. The firewalls must conform to Title 20 CFR Section 679.430 for demonstrating internal controls and preventing conflicts of interest.

The OSO must coordinate the service delivery of required one-stop partners and service providers. The OSO is responsible for the cohesive way in which partners and service providers interact with each other and how services are offered to all customers. The OSO will ensure the implementation of all Partner MOUs and convene and facilitate quarterly partner meetings to ensure provision of quality customer service as outlined in WIOA and scope of work.

#### **One-Stop System Allocations (\$ not-to-exceed)**

January 1, 2019 to June 30, 2020 (18 months)

As referenced in the prior Agenda Item, KRA Corporation was the highest scoring bidder for the components listed above.

The above funding recommendations are based on best estimates at this point in time. All WIOA Agreements will contain a thirty (30) day termination clause that may be implemented when there are deficiencies in the Contractor's ability to deliver services as outlined in the Statement of Work. If required, additional contracts for FY 2019-20 will be presented to the OCDB for approval in February 2019. Working Wardrobes and Orange County Asian Pacific Islander Community Alliance (OCAPICA) were procured through the Employment and Economic Development Services RFP for FY 2018-19. Working Wardrobes is providing the Senior Community Service Employment Program and OC4VETS. OCAPICA is providing the Welfare-to-Work Employment Programs. These contracts were for a one-year term ending June 30, 2019.

As other funding streams become available, the OCDB reserves the right to continue to fund the One-Stop System utilizing approved providers. The OCDB may incorporate other entities that have submitted a 'fundable' proposal under the Title I Career Services and One-Stop Operator RFP, competitively procure other providers, and/or fund additional activities that are in the best interest of the OCDB.

#### **RECOMMENDATIONS:**

- 1. Approve funding recommendations as outlined "One-Stop System Allocations (\$)" above.
- 2. Approve recommendation to enter into contract negotiations with KRA Corporation within the not-to-exceed Total Funding parameters referenced in Recommendation #1.
- 3. Approve cost contingency increases not to exceed a total of 10% of the first year contract amount, pursuant to County Contact Policy Manual Section 2.2-113.
- 4. If negotiations do not yield a contract, authorize staff to negotiate with the next ranked fundable provider(s) as procured through the WIOA One-Stop System Operator & Career Services RFP or through other means authorized by the County Contract Policy Manual.
- 5. If allocated funds and/or the carry-in from FY 2017-18 are less than or greater than the estimated amounts, authorize staff to adjust allocations accordingly.





#### BACKGROUND


The Workforce Innovation and Opportunity Act (WIOA) provides for a workforce system that is accessible to all job seekers, customer centered, and training that is job-driven. The Adult and Dislocated Worker programs provide training and employment services in the Orange County One-Stop Center system, and are required partners. Under WIOA, partner programs and entities that are jointly responsible for workforce and economic development, educational, and other human resource programs, collaborate to create a seamless customer-focused One-Stop Center System that integrates service delivery across all programs to make it easier for workers to access the services they need to obtain skills and employment.



# LEAP-2 JAIL PROGRAM


#### BACKGROUND

The County of Orange/OC Community Services and the OCDB were awarded a \$500,000 grant by the U.S. Department of Labor to implement the Linking to Employment Activities Pre-Release (LEAP) 2 program. The LEAP 2 program aims to establish a Transition Center within the Central Women's Jail and Intake Release Center and assist female offenders in preparing for work upon release. The project serves AB109 inmates who are 60-90 days away from release. The goal of the project is to improve the employment outcomes for transitioning offenders by leveraging and building upon the effective strategies that currently exist within the jail facilities and in the Orange County One-Stop Center System. This innovative and unique grant proposal was made possible as a result of OCDB's collaborative relationships with the OC Sheriff's Department, Probation Department and the OC Health Care Agency.





During this time, 100% of the wage is paid directly to the participant.

# NATIONAL DISLOCATED WORKER GRANT 2017 WILDFIRES


### BACKGROUND

The Orange County Development Board (OCDB), in coordination with OC Parks, was awarded \$1,000,000 in emergency funding from the State Employment Development Department for the 2017 California Wildfires. On October 9, 2017, the Canyon Fire 2 started near the intersection of the 91 and 241 freeways in Orange County. Of the more than 9,000 acres estimated damaged in the Canyon Fire 2, 7,060 acres are within four County park properties managed by OC Community Resources/OC Parks.
